2. The topper candidates at vocal / Instrumental field & Dance field at Bharat Sanskriti Yatra at Thailand & Dubai will free of cost participation (full package) at Malaysia Festival. .
3. The 1st / 2nd /3rd winners of Bharat Sanskriti Yatra 2022 will get concession @15% / @10% / @5% of total package cost.
4. Any interested candidates can join in the given competition of the Bharat Sanskriti Yatra in abroad and has to pay the complete amount of the package.
